- COVID-19 update /campus reopening (Martine Bergeron)
 - i. Vaccination clinic Negotiation underway with the Mayor to obtain additional vaccines were approved, the vaccination clinic will be reopening, and with the number of vaccines available, it will be open to staff, students, and community. The testing center is now in Sports complex and will shut down when the vaccination clinic reopens.
 - ii. Return to work policy With the expected return of some employees on campus as of 21 June a policy is being developed to provide guidance on working from home, to be published by end of the month
 - iii. Phase 1 reopening province is in phase 1 reopening, which allows outdoor gatherings up to 10 persons with physical distancing. Might be able to move to phase 2 by July 2. Gatineau is in yellow zone, and border restrictions have been relaxed. Reopening plan might be dependent on vaccination progress, the government isn't saying much on this. Sports services is reopening exterior fields per phases. Many food locations are reopening as of June 21st, then along with buildings reopening. Summer camp registration is also open.
 - iv. Ambassadors There will be an increase in ambassadors' routes with buildings reopening and some ambassadors will be redirected to busier buildings and Sports complex vaccination clinic.
 - v. All 11 residences will be open, though with a request to limiting residence occupancy to 1 person per room
 - vi. 22000 students are expected on campus as of September, as these students have at least 1 course in person.
- Designated Substances project (Martine Bergeron)
 - i. Reassessment of 13 buildings is completing this week, and we'll be going out to tender for construction (abatement/repair) of poor condition material identified, as of next week
 - ii. Will be initiating the process for reassessment and repair of other buildings
- Syringes on campus (Nicholas Lavoie)
 - i. Power Point presentation. Noticed a steady increase of needles during the pandemic. Protection recuperated more syringes than there are reports. Presence is observed throughout campus, but Rideau, Friel and other areas were identified as Hot spots/clusters. A walkaround took place to identify possible betterments recommendations include increasing lighting, cleaning up the foliage, repairing damage fencing, installing door closers, increasing camera coverage, etc. 290 Rideau parking has been closed. Needle hunters (city of Ottawa) walk-around 1-2x per day, they've added a route along uOttawa hot spots. uOttawa also reached out to community shelters and will seek to engage the nearby residences to report.
 - ii. Protection will dedicate resources to vaccination clinic 2 dedicated security guards to monitor the clinic
- Modify/Improve discussions of this committee (Martine Bergeron)
 - In the hopes to engage worker members in between committee meetings, incident information will be circulated weekly; inspections and program/document review will also take place between meetings
