# 1.03 Business arising from the Minutes of the May 5th, 2014 meeting\*

#### 1.04 New Business

## a) Presentation TA & Scholarships

L. St Pierre presented a detailed report with statistics on the research and teaching assistantships. L. St Pierre suggested an awareness campaign to be launched for professors and researchers regarding the hiring of students who are on admission scholarships; strategies to help the faculty fulfill its commitments towards those students are needed.

#### b) Enrollment Graduate studies \*

V. Khayat presented an update of graduate student admissions and presented the figures over the last 5 years. V. Khayat noted that there is a slight drop in enrolment. She will verify the number of the international students and provide an update to the Executive Committee at a later date. It was noted that the faculty does not receive BIUs for international students.. A recruitment strategy is needed to attract more francophone students as well as more international students. V. Khayat and C. Morin will inquire regarding procedures in other faculties.

## c) Leaning Center

The Dean gave an overview on the creation and location of LC which will be attached to the Faculty of Education. The Dean stated that construction will be carried out to extend Lamoureux on the east side of the building. The LC will include four multimedia classrooms to develop online courses, food services on the main floor as well as two large auditoriums. The Resource Centre, which is very important to the Faculty and has been integrated in our programs and open to all students of the university, will be relocated. Construction is slated for right after the CSSE conference in May 2015 and is projected to take two years. The Dean confirmed that an official announcement of LC construction will be sent by e-mail by next week.

# d) <u>Mandatory training for all the staff of the University (Accessibility, violence prevention, respect</u> in the workplace training, team work)

The Dean stressed the importance of the trainings that the university offers to the support staff and professors and the impact of those trainings on the performance and professionalism in the workplace and off the campus. The mandatory training modules include:

- Accessibility (support staff/professors)
- Violence prevention
- Respect in the workplace
- Team work

These training modules are to be completed online; C. Morin will send an e-mail reminder to all personnel so that we comply with the university regulations.

## e) Hiring Committee selection

The Faculty of Education's postings for five tenure-track positions is now closed and we have received several quality applications. There are two positions in Educational Technology (one Anglophone and one Francophone), two positions in Health Professions Education (one Anglophone and one Francophone) and one in Administration scolaire (Francophone). The selection committees at the Faculty of Education are comprised of one Vice Dean, one Program Director, two professors (one of which must be in the concentration), and one student. The Executive Committee discussed the advantage of expanding two selection committees because of affiliations with other faculties and services.

## g) Graduate student Writing Retreat

The graduate students association is once again organizing its annual writing retreat and they are soliciting some funding from different faculties to subsidize part of their retreat. Last year there were 14 students from the Faculty of Education who participated. The Executive Committee saw long-term value in this initiative in that it directly assists participants with their research writing. The graduate students association is requesting \$2500 from the Faculty of Education, \$1000 more than last year.

## i) Faculty of Graduate and Postdoctoral Studies (FGPS)

A committee made recommendations to the Vice President Academic and Provost and another committee has been struck to examine how these recommendations could be implemented.
