# 4.01 Adoption of the Agenda

## 4.03 Business Arising from the Minutes of the November 9, 2015 Meeting

#### Hiring Plan of New Faculty Members

The Dean reminds the committee that three positions are currently posted and the closing date is December 31, 2015. The Faculty members are encouraged to reach their contacts in order to get names of potential applicants for the positions. Brief discussion on the composition of the hiring committees follows.

#### CV Uniweb

A reminder regarding the importance to undergo the training session for the Uniweb platform. A session was held mid-November and the next one will be offered on December 16, 2015. The objective is to reach at least 50% of the professors before the end of the year.

### a) Faculty General Assembly
