Minutes

5.01 Adoption of the Agenda

By a resolution duly proposed and seconded, the agenda was unanimously adopted.

5.02 Adoption of the Minutes of the December 14, 2018 meeting

5.04 New Business

a) June Girvan – UN Decade for People of African Descent

June Girvan, a retired Education Officer, President of Black History Ottawa, made a presentation on the United Nations International Decade of People of African Descent (2015-2024) and the UN Declaration for the Decade that consists of 3 main points: development, justice and recognition. At the end of her presentation, Ms. Girvan advocates for the Faculty to show support for the school boards who have adhered to the declaration, by adopting the UN declaration.

After the departure of Ms. Girvan, members of the Faculty Council discussed the proposal.

Motion: It is proposed that the Faculty adopts the United-Nations Decade for People of African Descent.

Unanimous

It is also recommended that a declaration be prepared for adoption by the Council and an event be organised to unveil the declaration in the presence of Ms. Girvan.

A draft of the Faculty's declaration will be submitted to the Faculty Council for adoption.

b) Budget Update

Budget projections for 2019-2020 were submitted to Central Administration. The University's approval for envelopes 1 and 2 are yet to be received.

c) Approval of the revised hiring committee for the positions of Mathematics Education and French Education

The Dean introduces the composition of the revised committee with the addition of two new members. Professor A.-M. Dionne requests to be removed from this committee. The proposed revised committee is therefore composed of:

d) Admissibility of students with Ontario College degrees to Graduate Studies

The Directors of Graduate Studies of the Faculty propose that applications from potential candidates holding a 4 year bachelor degree from an Ontario College be evaluated on a case-by-case basis. For the moment they are not considered for admission except when an exception request is made. Conditions for admission would be:

- 1. That the College is recognized by the Ministry of Training, Colleges and Universities and is authorized to deliver bachelor's degree programs;
- 2. The applicant holds a minimum cumulative average of 7.0.

Motion: It is proposed by E. Duplàa, seconded by A. Samson, that the admissibility of students with Ontario College degrees to Graduates Studies at the Faculty of Education be approved with the conditions stated above.

e) Amendment to the Faculty Bylaws

A few minor changes were proposed to the Faculty Bylaws: "co-directors" of Graduate Studies was replaced by "directors". The nomination process of the Vice-Dean, Governance and Student Affairs was changed to match that of the two other Vice-Deans.

Motion: It is proposed by A. Samson, seconded by A.-M. Dionne, that the modifications to the Bylaws be approved.

h) Faculty Advisory Circle proposal

One of the goals of the Faculty is to strengthen the participation of our partners in Faculty life. In order to do so, the Dean proposes the creation of a Faculty of Education Advisory Circle. This Advisory Circle would consist of up to 16 members: 8 from the francophone sector and 8 from the anglophone sector. They should represent the diversity of Canadian society, be representatives of key partner sectors and have relevant expertise.

Motion: It is proposed by S. Chitpin, seconded by D. Smith, that the proposal for the Faculty Advisory Circle be approved
