# MESSAGE from the STEERING COMMITTEE

The year 2020-2021 has been rich in developments for the Interdisciplinary Research Laboratory on the Rights of the Child (IRLRC). Like everyone else, we had to adapt to the COVID-19 pandemic. Initially we experienced the shock of event cancellations and restrictions on our movements. As early as March, we had to cancel the annual conference scheduled for May 2020. We have also seen the devastation of the pandemic in the field of children's rights. The IRLRC blog bears witness to actual and potential violations of children's rights in relation to the pandemic, whether it be in education or in the protection of vulnerable children.

However, we have also seen positive developments. As the months went by and we had to make adjustments, opportunities became apparent. For example, we were able to hold our lunchtime lecture series with broader participation and speakers from across the country. Indeed, the use of online meeting platforms has improved our ability to reach people outside the region. Our lunchtime conferences were timely, addressing topics such as anti-racism, climate action and the impact of the pandemic on education. As for the annual conference that was cancelled in 2020, it was rescheduled in a virtual format and took place, with international participation, on May 20 and 27, 2021.

In addition to the events, the IRLRC has experienced structural developments. Our coordinator, Line Bissonnette, who had supported the Laboratory's operations since almost the beginning of its existence, took her well-deserved retirement. We are grateful for her unparalleled dedication! Thus, a new chapter has begun for IRLRC with an agreement signed between IRLRC, the Civil Law Section and the Human Rights Research and Education Centre (HRREC), ensuring the continuity of the Laboratory's operations in collaboration with these actors. This new development came on the heels of the new IRLRC membership procedure and is followed by a new structure that includes the participation of a student member in the IRLRC steering committee.

It is also worth mentioning the re-launch of the assistantship competition allowing IRLRC's academic members to launch interdisciplinary research projects in children's rights, thanks to funding from the Faculties of Social Sciences and Education. In addition, this year we expanded the essay competition to students from universities that host members of the Canadian Association of Human Rights Institutions (CAHRI).

Regardless of these positive developments for the IRLRC, we hope to see a return to a better situation in the coming year, not only for the Laboratory and its members, but especially for the children suffering from the COVID situation around the world.

# ABOUT the IRLRC

The Laboratory was created following an international conference on the rights of the child in March 2007. The purpose of the IRLRC is to foster interdisciplinary research on issues related to children's rights and well-being. The range of research initiatives conducted by members and promoted by the Laboratory is vast and rich. A general framework for understanding the research conducted at IRLRC is to recognize the individual identity of the child when it comes to his or her rights. The framework also emphasizes the different systems that influence children and the study of children's rights, including families, schools, neighborhoods, the legal system, the child welfare system, and societies more generally.

In order to foster the development of research partnerships and to encourage the initiatives of its members, the Laboratory has grouped the research axes it favours under four complementary themes:

- the Child and the Law
- the Child and the Family
- the Child, the State and Society
- reflections on Child-Focused Research Methodologies

#### **IMAGES OF JUSTICE: Children & Human Rights**

The Laboratory partnered with CONTEKST, the School of Child and Youth Care (Faculty of Community Services, Ryerson University), the Human Rights Research and Education Centre (HRREC), and the *Canadian Journal of Children's Rights* (Landon Pearson Resource Centre for the Study of Childhood and Children's Rights) to create a virtual exhibition of cartoons on the rights of the child, their freedoms, as well as various political, social, and legal issues.

An international jury, which included a high school student from Canada, selected ten works from among 390 submissions coming from 34 countries. The public was invited to vote online to choose the winning cartoon.

The grand prize winner of this edition of Images of Justice was Walter Toscano from Peru.

#### Children's Access to and Participation in Justice: Critical Assessment

The sessions defined children's access to justice in a global way, by addressing current challenges, asking questions that have not yet been asked and by bringing new answers to existing problems. Simultaneous interpretation was provided over both half-days of the conference for participants from around the world. The event received the generous support of Accès au Droit et à la Justice (ADAJ), the Faculty of Law, Civil Law Section, the French Embassy in Canada, the Social Sciences and Humanities Research Council (SSHRC) and the University of Ottawa.

### **TEACHING**

The Laboratory created a course for graduate students entitled *Children's Rights: An Interdisciplinary Approach* in 2010. During the 2021 Winter semester, the course was offered in English by Professor Christine Gervais, Faculty of Social Sciences, Department of Criminology. Ten (10) graduate students from the Faculties of Law, Education, Social Sciences (Psychology, Social Work), Arts (Music) and Health Sciences participated in this session. To date, the Laboratory has trained seventy-one (71) graduate students who participated in nine offerings of the course.

# RESEARCH ASSISTANT COMPETITION

A new Research Assistants Competition was organized in winter 2021 and the project proposed by Professors and members Christine Gervais and Elisa Romano titled *Study on Child-to-Parent Violence* and *Aggression in Adoptive Families in Canada* was funded in the amount of \$3,000.

The funding will be used to support the preparation of an external grant application.


