## **ENGLISH PROGRAM COURSE FAIR FOR 2023-2024**

The Course Fair provides information on upper year course offerings for 2023-2024 and on course selection planning. The Course Fair begins with a plenary overview presentation by Vice-Dean Wiseman at 11:30AM in FTX147. Students will have an opportunity to circulate around designated rooms (see below) to meet with participating professors, CPDC staff and representatives of options and other programs to find out more about the general content of courses in thematic areas or about specific courses or other learning opportunities. Not all professors can participate in the Course Fair and so specific information may not be available for some of the courses listed.
