Professor Gao started his career as the first Chinese lawyer at the WTO Secretariat. Additionally, he has held visiting positions at several institutions including Stanford Law School, European University Institute, and the University of Geneva. - 2. "Frontiers Of Legality: Understanding The Public Policy Exception In Choice Of Law": Langille examines the public policy exception in choice of law doctrine. She proposes reconceptualizing this exception as a tool for courts to analyze foreign law and ensure its compliance with the rule of law, providing a justification for the exception's inclusion in choice of law doctrine and a coherent interpretation of the doctrine.
