These training requirements apply to those who begin training on or after July 1, 2019.

The following training experiences are required or recommended, as indicated.

TRANSITION TO DISCIPLINE (TTD)

The focus of this stage is the introduction of new trainees to the specialty of Obstetrics and Gynecology; orientation to the structure, policies, resources, and expectations of the program; and exposure to the various settings relevant to Obstetrics and Gynecology. During this stage, trainees will reconfirm the competencies achieved in medical school and perform initial assessments of uncomplicated obstetrics and gynecology patients.

FOUNDATIONS OF DISCIPLINE (F)

The focus of this stage is the development of the skills required to assess and manage patients with common and uncomplicated presentations in Obstetrics and Gynecology, including labour and delivery; routine preconception, antenatal, and postpartum care; initial management of urgent and emergent gynecologic presentations; and counselling on issues related to family planning. During this stage, trainees will demonstrate their technical skills performing minor gynecologic procedures and uncomplicated cesarean sections under supervision. Trainees at this stage will also begin to incorporate new evidence into patient care via critical appraisal activities.

CORE OF DISCIPLINE (C)

This stage builds on the skills and knowledge of the Foundations stage to add the diagnosis and management of the breadth of obstetric and gynecologic patient presentations in progressively more complex situations with increasing autonomy. Trainees perform the core technical skills required for practice in Obstetrics and Gynecology, including the use of ultrasound, the performance of operative vaginal deliveries, complex cesarean sections, and vaginal, laparoscopic, and open abdominal procedures.

TRANSITION TO PRACTICE (TTP)

The focus of this stage is consolidation of clinical, surgical, and administrative skills in preparation for practice in Obstetrics and Gynecology. Trainees demonstrate independent management of complex patients in all relevant care settings and patient-centred communication skills in difficult situations. This stage includes taking responsibility for administrative tasks, such as teaching, leading, and scheduling junior learners, and participating in QA and QI initiatives while still providing high quality patient care.

CERTIFICATION REQUIREMENTS

Royal College certification in Obstetrics and Gynecology requires all of the following:

- 1. Successful completion of the Royal College examination in Surgical Foundations;
- 2. Completion of all elements of the Royal College Surgical Foundations Portfolio;
- 3. Successful completion of the Royal College examination in Obstetrics and Gynecology; and
- 4. Successful completion of the Royal College Obstetrics and Gynecology Portfolio.

NOTES:

The Obstetrics and Gynecology Portfolio refers to the list of entrustable professional activities across all four stages of the residency Competence Continuum, and associated national standards for assessment and achievement.

MODEL DURATION OF TRAINING

Progress in training occurs through demonstration of competence and advancement through the stages of the Competence Continuum. Obstetrics and Gynecology is planned as a 5-year residency program. There is no mandated period of training in each stage. Individual duration of training may be influenced by many factors, which may include the student's singular progression through the stages, the availability of teaching and learning resources, and/or differences in program implementation. Duration of training in each stage is therefore at the discretion of the faculty of medicine, the competence committee, and the program director.

Guidance for postgraduate medical education offices

The stages of the Competence Continuum in Obstetrics and Gynecology are generally no longer than

Transition to Discipline – 4 blocks* Foundations of Discipline – 22 blocks Core of Discipline – 33 blocks Transition to Practice – 6 blocks Total duration of training – 5 years

Guidance for programs

The Royal College Specialty Committee in Obstetrics and Gynecology's suggested course of training, for the purposes of planning learning experiences and schedules, is as follows:

2-4 blocks* in Transition to Discipline
18-22 blocks in Foundations of Discipline
24-33 blocks in Core of Discipline
6 blocks in Transition to Practice

*One block is equal to 4 weeks

Credit for training in the United States of America

Those who have completed four (4) years of residency in Obstetrics and Gynecology in Accreditation Council for Graduate Medical Education (ACGME) accredited programs in the United States of America may fulfil the requirements above if they also complete one (1) of the following:

1. One (1) year of American Board of Obstetrics and Gynecology (ABOG) accredited clinical fellowship in Gynecologic Oncology, Maternal-Fetal Medicine, or Gynecologic Reproductive Endocrinology and Infertility, or urogynecology/reconstructive pelvic surgery

or

2. Current ABOG certification as a Diplomate in Obstetrics and Gynecology
