# Eligibility Criteria

The applicant must:

- 1. Be a faculty member at the University of Ottawa Faculty of Medicine, who is applying to fund outgoing mobility for themselves or incoming mobility for a counterpart at KCMUCo
- 2. Demonstrate an understanding and commitment to the ethical principles of global health, as set out in the Brocher Declaration
- 3. Have an identified counterpart at KCMUCo
- 4. Demonstrate a commitment to advancing the global health goals defined by the Faculty of Medicine in the 2020-2025 Strategic Plan
- 5. Commit to providing a 1–2 page report on their activities in the format requested by the International and Global Health Office (IGHO)

The mobility activity must:

- 1. Fall within the Clinical Partnership Activities or Public Health Partnership Activities interrelated pathways indicated above
- 2. Be built on an education and capacity building model
- 3. Focus on activities that respond to priority needs identified by KCMUCo
- 4. Align with the theory of change and logic model established for the KCMUCo partnership

# Value of the funding

Outgoing mobility: up to \$3,000 Incoming mobility: up to \$5,000

Funding will be reimbursed up to the set amounts indicated above. Each applicant will be responsible for managing all associated travel expenses as per the policies and procedures of the University. For uOttawa Faculty, this will involve using the Concur system to request cash advances (if needed) and to request reimbursements up to the stipulated amount. For incoming faculty, the uOttawa faculty applicant will be responsible for supporting their Tanzanian counterpart throughout the process.

Upon approval of funding, IGHO will provide details on eligible costs and all associated financial processes. Recipients will be responsible for reading, understanding, and adhering to uOttawa travel policies and regulations.

Eligible expenses include:

- Equivalent of economy class flight
- Accommodations costs
- Visas
- Travel/health insurance while overseas
- Local transportation and meals
