## Technological Unemployment Symposium held at Congress 2015



We are pleased to announce that the ISSP's interdisciplinary symposium "Technological Unemployment and the Future of Work" held on Wednesday June 3rd was a great success! This event was part of the <u>Congress of Humanities and</u> Social Sciences 2015.

In all, over one hundred Congress participants and members of the public came to hear our keynote speaker <u>Nick</u> <u>Bostrom</u> discuss the paths towards advanced artificial intelligence. This keynote speech was followed up by

<u>Wendell Wallach</u>'s commentary about technological factors such as robotization, artificial intelligence and life span extension that are converging to reduce future demand for human labour. The symposium concluded with a panel discussion moderated by ISSP Fellow **Peter Calamai** featuring Nick Bostrom, Wendell Wallach and <u>Wendy Cukier</u>, Vice-President of Research and Innovation at Ryerson University, where each panelist shared views on the multiple and complex challenges relating to jobs and technology in the 21st century.

Rounding out an already great agenda, the Canada Science and Technology Museums Corporation provided several artifacts in the form of a mini museum exhibit highlighting the interaction between human labour power and technology in a historical context.

This year's keynote speaker was Prof. **Carlos Henrique de Brito Cruz** who delivered a talk entitled "<u>Science and Technology Policy in Brazil. The Role of Sub-National Initiatives</u>".

The annual Bromley event provides graduate students with the opportunity to meet and

exchange ideas with senior science and technology (S&T) policy advisors from various countries, sectors and levels of government. It is the only opportunity of its kind in Canada and perhaps the world.

### The ISSP Welcomes New Fulbright Canada Scholars in 2015-2016

We are happy to announce that two Fulbright Canada scholars will be joining the ISSP during the 2015-2016 academic year.



Wendell Wallach, who will be joining us in October 2015, is consultant, ethicist and scholar at Yale University's <u>Interdisciplinary Center for Bioethics</u>. He is also a scholar with the <u>Lincoln Center for Applied Ethics</u> (Arizona State University), a Fellow at the <u>Institute for Ethics & Emerging Technology</u>, and is a visiting scholar at The <u>Hastings Center</u>. He is also the author of several books and articles relating to technology and applied ethics, including most recently <u>A Dangerous Master: How to</u>

Prevent Technology From Slipping Beyond Our Control.

**Nigel Cameron**, who will be joining us in March 2016 is President and CEO of the <u>Center for Policy on Emerging Technologies</u> (C-PET), a non-partisan Washington, DC think tank established in 2007 to encourage long-term thinking on the policy and broader social impacts of emerging technologies. Previously he was a Research Professor and Associate Dean at the Illinois Institute of Technology in Chicago, where he led projects focused on the social, business and policy impacts of developments in biotechnology and nanotechnology.



Both Wendell and Nigel will be joining the ISSP for six-month terms and will be housed here on campus at the ISSP.

ISSP Director **Marc Saner** will be speaking at the 14th annual meeting of the <u>Science and</u> <u>Democracy Network</u> at Harvard University on June 26th, 2015. The title of his talk will be: "How Transferable is the Science-Policy Interface Design of the US National Research Council and the Council of Canadian Academies?". The paper associated with his talk is entitled "Punctuated versus Gradual Designs of Science/Policy Interfaces."

Marc Saner also recently co-authored a new paper (with Gary E. Marchant) which was published in the winter 2015 issue of <u>Jurimetrics</u> titled "<u>Proactive International Regulatory</u> <u>Cooperation for Governance of Emerging Technologies</u>".
